BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF OAKWOOD HILLS, ILLINOIS, as follows:

WHEREAS, the Village of Oakwood Hills is authorized to adopt ordinances for the
preservation of public health, safety and welfare of its residents;

WHEREAS, it has been determined that certain modifications are necessary to the
Village of Oakwood Hills Municipal Code concerning certain snow and ice removal practices;
and

WHEREAS, the President and Board of Trustees desire to better define certain
permissible behavior in relation to the plowing, shoveling, blowing or other removal of the
accumulation of snow and/or ice from private property and the placement of snow and/or ice on
Village Streets or other Village property and to put property owners and others on notice as to
what conduct or conditions will be considered unlawful.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF
TRUSTEES OF THE VILLAGE OF OAKWOOD HILLS, McHENRY COUNTY, ILLINOIS,
as follows:

SECTION ONE: That CHAPTER 14 of the Oakwood Hills Municipal Code shall be amended by the insertion of a new Section 14-115 entitled “**Improper Snow/ Ice Placement,**” which shall state as follows:

Section 14.115 Improper Snow/ Ice Placement.

It shall be unlawful for any person, firm or corporation to deposit snow or ice that has been removed or relocated from any portion of private property, by shoveling, plowing, sweeping, pushing, blowing, dumping or removing in any other manner, onto a public road way or any Village of Oakwood Hills property, including but not limited to the Municipal Park (as that term is defined herein), Village Parking lots, beach property, expressly including the shoreline and the waters of Silver Lake, and/or any other Village of Oakwood Hills owned property acquired hereafter.

Any person, firm or corporation found to be in violation of this section shall be guilty of a petty offense and upon conviction thereof shall be fined not less than Twenty Five dollars (\$25.00) and no more than Five Hundred dollars (\$500.00) for each offense.

SECTION 2: That Section 1-114 of CHAPTER 1 of the Oakwood Hills Municipal Code shall be amended by the insertion of a new offense known as “Improper Snow/Ice Placement” and penalty for same, at the bottom of the table, and shall state as follows:

<u>Offense</u>	<u>Municipal Code</u>	<u>Penalty if paid Before “due” date on ticket</u>	<u>Penalty if paid after “due” date and on or before final notice date” on ticket</u>
Improper Snow /Ice Placement	Section 14-115	\$ 25.00	\$ 50.00

SECTION 3: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate, or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 4: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed, to the extent of such conflict.

SECTION 5: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.


