AN ORDINANCE AMENDING THE VILLAGE CODE
OF THE VILLAGE OF OAKWOOD HILLS

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF OAKWOOD HILLS, ILLINOIS, as follows:

WHEREAS, it is the policy of the Village of Oakwood Hills to promote water conservation
and water quality within the Village limits; and

WHEREAS, Silver Lake is located within the corporate limits of the Village of Oakwood
Hills; and

WHEREAS, owners of property abutting Silver Lake have in the past pumped water from
the lake for the purpose of watering outside landscape and lawn watering.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF
TRUSTEES OF THE VILLAGE OF OAKWOOD HILLS, MCHENRY COUNTY, ILLINOIS, as
follows:

SECTION 1: That Chapter 14 OFFENSES-MISCELLANEOUS Section 14-114 shall be
added as follows:

14-114 It shall be unlawful for any person, firm or corporation to draw water by any means
from Silver Lake, to pump or use any other method for the removal of water from Silver Lake for
the purpose of outside landscape or lawn watering or any other use upon their property abutting
Silver Lake.

Any person, firm or corporation violating the provisions of this Ordinance shall be fined in
accordance with the provisions of Section 14-106.6 Enforcement, Violations and Penalties.

SECTION 2. If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 3. All Ordinances or part of Ordinances in conflict herewith are hereby repealed to the extent of such conflict.
